

OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE PARTICIPANT'S CHANCE OF WINNING. VOID WHERE PROHIBITED.

1. ELIGIBILITY

Cárdenas Marketing Network, Inc. ("CMN") shall be the sponsor of the "Name That Tune Ticket Giveaway" ("Promotion") which is open to all legal residents of the United States who are eighteen (18) years or older at the time of entry. Proof of residency and age may be required. Void where prohibited. Employees and directors of CMN or individuals involved with the design, production, execution, or distribution of the Promotion and the immediate family and household members of such individuals, are not eligible to enter or win. "Immediate family members" shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, regardless of where they live. "Household members" shall mean people who share the same residence at least three (3) months a year, whether related or not.

2. AGREEMENT TO OFFICIAL RULES

By entering this Promotion, Participant accepts and unconditionally agrees to be bound by these Official Rules and the decisions of CMN, whose decisions shall be final and binding in all matters related to the Promotion. 3. PROMOTION PERIOD

The Promotion will be run on the following three (3) dates: April 13, 2017; April 20, 2017; and April 27, 2017 (each a "Promotion Date" and collectively the "Promotion Dates"). Entries must be received on one of the Promotion Dates. CMN is the official timekeeper for this Promotion.

4. HOW TO ENTER

On each of the three (3) Promotion Dates, CMN will post a tweet containing one (1) video clip to its Twitter account @cmnevents consisting of a three (3) second audio clip from a Carlos Vives song. Eligible participants may enter to win by replying to the tweet with the name of the Carlos Vives song featured in the audio clip. All entries must be received on the Promotion Date. CMN, in its discretion, may promote, advertise, and/or market the Promotion through any and all available mediums and methods. Limit one (1) entry per Participant per Promotion Date.

5. CONSENT & PUBLICITY

By entering the Promotion, Participant consents to allow CMN and its affiliates to use Participant's full name, city and state of residence, testimonials, biographical information, voice, opinions, image, likeness, photographs, and statements made by or attributed to Participant, in perpetuity for any and all purposes, including but not limited to marketing and Promotion purposes in any media now known or hereafter discovered worldwide, including the world wide web, without further limitation, restriction, compensation, notice, review, payment, consideration, or approval by Participant except where prohibited by law. In addition, Participant consents to receive emails or other messages from CMN, including but not limited to other events, marketing and Promotion purposes, consumer insights, etc.

6. PRIZE DESCRIPTION

Prizes will be awarded for each Promotion Date according to the following schedule:

Winners will be randomly selected by CMN from all eligible entries on each of the Promotion Dates. Winners will be notified by direct Twitter message within one (1) day after each Promotion Date and will receive the Prize indicated in the

table above. Ticket locations will be subject to availability and as determined in CMN's sole discretion, and will be available for pick up at will call unless otherwise directed by CMN.

All transportation, lodging, meals, gratuities, personal purchases, and any and all other expenses and incidental costs are solely the responsibility of Winner. Approximate retail value of the Prize is seventy dollars (\$70.00) for each single ticket and one hundred forty dollars (\$140.00) for each pair of tickets. Winner shall be responsible for any taxes and fees associated with the Prize receipt and/or use. Any federal, state, and local tax liabilities, as well as any other costs and expenses not specified herein as being awarded are the sole responsibility of Winner. The Prize must be taken as offered and cannot be sold or traded, substituted, redeemed or exchanged for cash, credit, or alternative prizes, except at CMN's sole discretion. CMN reserves the right, in its sole discretion, to substitute the Prize with a prize of equal or greater value. No credit or reimbursement shall be provided if a Prize is not taken. The Prize cannot be combined with any other Promotion offer or offers provided by CMN. CMN will make one (1) attempt to contact Winner, and if Winner does not respond to either contact attempt, the Prize shall be forfeited and no other prize shall be provided to Winner. If Winner cannot accept the Prize as specified, CMN has the discretion to award the Prize to an alternate winner (time permitting). There shall be no cash equivalent for the Prize. The Prize is non-transferable and no substitution shall be made except as provided herein at CMN's sole discretion.

8. HOW TO CLAIM A PRIZE

The Winner shall be notified using the Twitter account provided with the entry. Once notified, Winner has twenty-four (24) hours to claim the Prize by contacting CMN. The Prize may be awarded to Winner, subject to verification of Winner's eligibility and full compliance with the terms of these Official Rules. Failure by Winner to respond to the message within twenty-four (24) hours of notification shall result in Winner's disqualification and CMN may select an alternate winner in the same manner (time permitting).

A Participant selected as a Winner may be required to complete, sign, and return a Notarized Affidavit of Eligibility, a Liability Release, and a Publicity Release within twenty-four (24) hours of Prize acceptance or an alternate winner may be selected by CMN (time permitting). Winner's guest (if applicable) may also be required to complete, sign, and return a Liability Release and a Publicity Release within twenty-four (24) hours of Winner's acceptance before Guest may participate in the Prize.

In the event of noncompliance with any of these time periods, the Prize shall be forfeited and an alternate winner may be selected (time permitting). Any alternate winner selected shall also be required to fully comply with these Official Rules and to respond to CMN within twenty-four (24) hours of the notification and complete, sign, and return an affidavit of eligibility and liability and publicity release within twenty-four (24) hours of acceptance. CMN is not responsible for suspended or discontinued Internet, landline, or wireless service, which may result in a potential winner not receiving initial Prize notification.

In the event: (a) potential winner cannot be reached for whatever reason after a reasonable effort has been exerted or the potential winner notification or Affidavit is returned as undeliverable; (b) potential winner declines or cannot accept, receive, or use the Prize for any reason; (c) of noncompliance with the above or within any of the aforesaid time periods; (d) potential winner is found to be ineligible to enter the Promotion or receive the Prize; (e) potential winner cannot or does not comply with these Official Rules; or (f) potential winner fails to fulfill the Affidavit-related obligations, the potential winner shall be disqualified from the Promotion and an alternate potential winner may be selected (time permitting), at CMN's sole discretion, from among the other eligible entries received. CMN reserves the right to modify the notification and Affidavit procedures in connection with the selection of alternate potential winner, if any.

9. ADDITIONAL LIMITATIONS

CMN and its respective parent, affiliate, and subsidiary companies, agents, and representatives are not responsible for any typographical or other errors in the offer or administration of this Promotion, including, but not limited to, errors in any printing or posting of these Official Rules, the selection and announcement of any Winner, or the distribution of the Prizes. Any attempt to damage the content or operation of this Promotion is unlawful and subject to possible legal action by CMN. CMN reserves the right to terminate, suspend, or amend this Promotion, without notice, and for any reason, including, without limitation, if CMN determines that this Promotion cannot be conducted as planned or should a virus, bug, tampering or unauthorized intervention, technical failure, or other cause beyond CMN's control corrupts the administration, security, fairness, integrity, or proper play of this Promotion.

10. DISPUTES

Except where prohibited, Participant agrees that any and all disputes, claims, and causes of action arising out of, or connected with this Promotion, or the Prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the appropriate court located in the State of Illinois. Any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion, but in no event attorneys' fees.
